The Macular Degeneration Association produces newsletters quarterly. The information provided is for those who have age-related macular degeneration, diabetic eye disease, glaucoma, geographic atrophy, dry eye disease, and cataracts. The newsletter provides educational information, new research, new drug therapies, clinical trials, and treatments. The newsletters go out to 49,200 doctors, patients, families, and caregivers. Brochures were designed and provided to doctors to help their patients navigate macular degeneration and find resources that can help. The Macular Degeneration Association has created a state-of-the-art website to provide an extensive number of resources and information to help those affected by macular degeneration and additional diseases that can affect macular degeneration. This website includes educational videos that are produced for patients, family members and caregivers. The website is ADA-compliant.

The Macular Degeneration Association (MDA) created informative and necessary educational programs for those affected by macular degeneration, diabetic macular edema, geographic atrophy, and dry eye disease. These programs not only provide information for the person affected by these eye diseases but also bring precautionary measures to their family members and helpful information for their caregivers. All programs feature experts in the field of retina or optometry providing information about risk factors, genetic predisposition, proper diagnosis, new treatment options, research information, clinical trials, and new drug advances. Participants are given a chance to interact with the doctor and ask questions. They are also able to share their challenges and successes with the other attendees.

In 2025, MDA funded research to Orange County Research for their project on Combination Therapy in Wet AMD and Geographic Atrophy, led by Rajiv Rathod, M.D. A donation was made to Good Days to help patients cover medication costs essential for preserving their vision. A grant was given to Women Make Movies for their film "Seeing Stars" the first fiction film about macular degeneration which is positioned to bring worldwide attention to the epidemic of vision loss, expanding support for services and retinal research that will lead to sight-saving treatments for millions of people.
